The Kenton County 4-H Horse Riding/Driving Program was created as another opportunity for 4-H Horse participants to be involved in more than participating at the fair at the county level. A log sheet was designed for the 4-H participant to keep track of the amount of time he/she spends riding or driving their horse.

How to participate in the Kenton County 4-H Horse Riding/Driving Program:

- 1. The program will run from September 1, 2023, thru August 31, 2024.
- 2. Be an enrolled Kenton County 4-H Member for the current year and complete 6 (six) educational hours.
- 3. Log the amount of time spent riding or driving your horse. You must ride a minimum of 15 minutes to be able to log your riding or driving time. This is to be actual time in the saddle, actually riding or driving your horse. You are not to log time that you are just sitting on your horse you must be actually riding. You are not to include tack time or any breaks taken during your riding or driving time.
- 4. You are only allowed to log a total of 3 hours per day for horse show and 3 hours per day for horse camp, 3 hours per each parade. If you log more hours than that they **will not** be counted.
- 5. <u>Make sure an adult (whoever supervised the ride) signs off on your log sheet every</u> <u>time that you ride. All Drill Team hours must be signed by one of the drill team</u> <u>coaches.</u>
- 6. Submit completed log sheets by **September 5, 2024** to the Extension Office.
- 7. All participants in this program, when they reach level 1 or higher, will receive their award at the Kenton County 4-H Awards Banquet.
- 8. Your logged time will be accrued over the years that you are in 4-H. You must turn in your log sheets every year to have them count. We will not count hours for previous years if a log sheet was not turned in on time for that year. There will be **NO EXCEPTIONS** to the above rules.
- 9. Each and every line item needs to be completed on the form. Use of ditto's or line is not acceptable and time indicated in this manner will be deducted.
